Vote Yes on Proposition 115

What we came to know as Initiative 120 or *Due Date Too Late*, the initiative to end abortion after 22 weeks gestation in Colorado, has a new name.

The initiative will appear on the Colorado November 3rd Ballot as **Proposition 115**. We are encouraging all pro-life folks to vote YES on Prop 115.

Pro-life organizations around the state are working hard to get the word out about this initiative so that Colorado voters understand what is at stake.

This is our best opportunity in years to make a substantive change to the obscene “anything goes” abortion laws in our state.

In El Paso County and throughout Southern Colorado, we are working closely with churches and other organizations to launch effective messaging. In fact, we just received several thousand ‘Palm Cards’ with important Prop 115 information and a darling photo of a baby.

Upon the death of Supreme Court Justice Ruth Bader Ginsburg, Students for Life America, pointed to the importance of the Justice who will replace her.

The President's Corner

Legalized child murder was foisted upon the United States by technically and morally corrupt conclusions of the U.S. Supreme Court in the *Roe v Wade* and *Doe v Bolton* decisions. (For information on how the *Roe v Wade* decision was [technically faulty](#). see *Abuse of Discretion: The Inside Story of Roe v Wade* by Clark Forsythe.)

Unfortunately, it was not the first time the Supreme Court made a mistake, nor has it been the last time. However, 47 years later, this [egregious mistake](#) has not been corrected. Why?

At this point we could review all the numerous efforts undertaken in the years since *Roe v Wade*, at the federal, state and local levels, to address the [egregious mistake](#). Some of the efforts have been partially successful and others failed due to Congress, legislatures, governors, courts, judges, political action committees, fake media, et cetera. In the end the [egregious mistake](#) still rules the land.

Let me get right to the point. Our government in the end is controlled by the voters and it is these voters who have left the [egregious mistake](#) in place. **The majority of the electorate is OK with child murder.** It is this electorate that has allowed and even promoted all the obstacles faced by efforts to correct the [egregious mistake](#).

Given our form of government, **the only way the [egregious mistake](#) can be corrected is for a majority of the electorate to compel its correction.**

Consequently, **we must build a pro-life majority in the [electorate](#).** At Pikes Peak Citizens for Life we are working on this goal through numerous efforts including the upcoming *Life Chain* and *Roses for Life*, our newsletters and website, our educational booths (stymied at the moment by the virus), presentations, the *Sidewalk Advocates* program, and support to other pro-life efforts such as *40 Days for Life*, *Life Network*, and currently the massive task of building support for *Proposition 115*, a late-term abortion ban in Colorado.

Also important in [correcting the egregious mistake](#) is encouraging all pro-life voters to vote for life. Amazingly, I still encounter people who are not registered to vote, or who have given up voting. **To build a pro-life majority, we must commit to voting in all elections. EVERY VOTE MATTERS – EVERY TIME.**

Sadly, the fake news media is working hard to cancel the pro-life message, meaning we have to work harder to have it heard. In the end, the pro-life message will prevail because it reflects reality. Let us work to bring reality back to our society as soon as possible. *Matt*

DNC “Freeze Out” Pro-Life Democrats

The National Catholic Register recently drew attention to the challenge pro-life Democrats faced at the 2020 Democratic National Convention.

“For the first time since 2000, the Democratic National Convention did not permit Democrats for Life of America (DFLA) to caucus as an official part of the convention and refused even to allow them to testify before the platform committee — the latest signs of the party’s overt hostility to the pro-life movement within their ranks.”

However, the freeze out by the DNC seems to be having an unexpected opposite impact, according to DFLA president Kristen Day who described “unprecedented” momentum and growth among pro-life Democrats.

Representative Dan Lipinski (D-Ill) who was recently targeted by pro-abortion groups, called the radical Democratic Party Platform “out of step with Democrats” and highlighted a DFLA analysis finding that in 389 out of 435 congressional districts a majority of voters support a ban on abortion after 20 weeks of pregnancy as well as support the Hyde Amendment prohibiting taxpayer-funded abortions.

Going further, Terrisa Bukovinac, founder of Pro-Life San Francisco and member of DFLA’s board of directors, points out Joe Biden’s betrayal of pro-life Democrats after years of claiming to support policies for life.

“Giving the example of the Hyde Amendment, she said that “at least 2 million lives have been saved by the Hyde Amendment, disproportionately Black, brown and indigenous children of color,” and yet pro-abortion activists in the party “are trying to make it seem like the Hyde Amendment is somehow discriminatory.”

Bukovinac said that, for her, “voting for pro-choice candidates or any candidate that’s going to massively violate fundamental rights, a vote for those candidates is complicity in those acts that we must not be enabling in any way.”

This energetic rise of pro-life Democrats is particularly interesting in our state, given the passionate advocacy for Proposition 115 by Colorado Democrats for Life – which could be the critical factor in whether the proposition to save pre-born children succeeds or fails in November.
