## COVID-19 and LIFE Issues – Welcome to Our Brave New World

PPCFL's July [LifeLine](#) article, "Studies Reveal COVID-19 Vaccine Risks" brought forth a strong response. One reader had not realized that every vaccine currently in use for COVID-19 has links to aborted fetal tissue.

We directed her to the exhaustive archives at *Children of God for Life* <https://cogforlife.org/guidance>.

A local doctor expressed a thoughtful concern: "I read your article on vaccine safety with some dismay. 7000 Coloradans have died of COVID-19... I agree that the vaccines were made from fetal cell lines or were tested by reagents containing fetal cell lines... I agree that vaccinating 12-16 year olds is possibly more dangerous than letting the disease run its course in that age group. However seeing how sick my unvaccinated adults have gotten with COVID and watching some of them die makes me very worried that your article may dissuade the unvaccinated from receiving life giving protection..."

Another local doctor asked: "Was the Wuhan virus Anti-Vaccine lead article in this month's LifeLine intended to dissuade your (mostly elderly) readers/contributors from getting vaccinated... or to make those who have been vaccinated feel guilty about have done so?"

We deeply appreciate the individuals who have taken the time to read and comment on the article, and we have invited additional conversation and opportunities for guest authors to share their experiences with COVID.

As the newsletter editor, I state unequivocally, **it was NEVER our intent to induce guilt or counteract advice the elderly have received from a doctor.**

The pressure to participate in this global mRNA experiment is intense – with celebrities, politicians, religious leaders, grocery stores and fast food chains urging every human being – even pregnant women and children – to march to the pharmacy and roll up a sleeve.

The blow-back is enormous against any person or organization (including PPCFL) who expresses concerns about startling results of [bio distribution studies](#)<sup>1</sup> (see links); [CDC-reported heart inflammation](#)<sup>2</sup>, or the [unknown long-term consequences](#)<sup>3</sup> of these injections on teens.

**Why is PPCFL even talking about this?** Isn't being pro-life just about abortion?

After World War II, the [Nuremberg Code](#)<sup>4</sup> established a set of **ethical principles for human experiments**, but scientists repeatedly conducted dangerous, often life-threatening experiments on prisoners, people of color, and even children as chronicled by Allen Hornblum in [Against Their Will: The Secret History of Medical Experimentation on Children in Cold War America](#).<sup>5</sup>

After [Thalidomide](#) caused children to be born without limbs and [Diethylstilbestrol](#) (DES) deformed the uterus of preborn daughters, the FDA shielded children in utero from drug trials. Those protections have eroded.

Recently, a study was announced for 1000 pregnant women being injected with Moderna mRNA-1273 vaccine. None of us know what will happen to the babies, but these are the *exact* outcomes [to be measured](#).<sup>6</sup>

- **Infants with Suspected Major and Minor Congenital Malformations** - those that have significant medical, social or cosmetic consequences, and typically require surgical intervention or are life-threatening (for example, cleft lip, spina bifida).
- **Pregnancy Complications** - may include preeclampsia, eclampsia, pregnancy-induced hypertension, antenatal bleeding, preterm labor, gestational diabetes, dysfunctional labor, premature rupture of membranes, placenta previa, postpartum hemorrhage, small-for-gestational-age (SGA) fetus & intrauterine growth restriction (IUGR), and non-reassuring fetal status.
- **Pregnancy Outcomes** - may include spontaneous abortions, fetal death or stillbirth, live birth, elective or therapeutic pregnancy terminations, preterm birth, ectopic pregnancies, molar pregnancies, maternal death, and COVID-19 diagnosis.
- **Infant Outcomes** - may include minor congenital malformations, size of gestational age, low birth weight, size for age, failure to thrive, hospitalization of infants, neonatal death, perinatal death, neonatal encephalopathy, respiratory distress in the newborn, neonatal/infant infection, infant death, and infant development.

With the response to COVID-19, our society has advanced beyond using aborted fetuses to develop medicines for the living. We are now experimenting on preborn and teenagers – knowing that children and teens rarely become seriously ill from COVID. (continued page 2)

## The President's Corner

Our modern world is literally overflowing with information of one sort or another, and quite often it is contradictory. So, how does one go about evaluating a source?

A common method has been to consider the credentials of the source and whether they apply to the information being disseminated by the source. So, medical information being provided by a doctor appears, at first glance anyway, as credible.

However, in testimony at the state capitol on pro-life bills, I have heard doctors take both sides of the abortion issue. Credentials, in this case, don't appear to tell us much.

I've also seen credentialed doctors (usually abortionists) powerfully refuted by middle school students with no credentials other than their life science classes. Again, credentials don't help us in this situation.

My own testimony has been rejected, I've been told, because I'm not a doctor. Yet doctors giving the same testimony as mine are ignored as well. Clearly, credentials are insufficient when it comes to evaluating a source.

If we are truly going to evaluate a source, we need to look beyond credentials, without ignoring them, and evaluate whether there are biases, conflicts of interest, or anything else that is obfuscating the truth, which is what we want to discover.

Such an effort requires looking at the statements issued as well as who is making the statements and then evaluating them based on what is most plausibly true and who is most likely to be least biased.

It is not a straightforward activity but it is necessary. At Pikes Peak Citizens for Life we continually engage in this activity in our endeavor to bring to you the most truthful accounts possible. *Matt*

We are injecting *children* in hope that it might benefit *adults*.

PPCFL acknowledges that doctors and individuals need to consider many different factors when evaluating whether to take or recommend the use of experimental medicines for patients, themselves or loved ones.

It is also valid for pro-life individuals to express concerns about the potential risks of medical experimentation on our human family – both born and preborn – and to **recommend that doctors consider alternatives** that don't involve using aborted fetal tissue.

### We now know there are alternatives to experimental injections.

[Jose Trasancos](#) of Children of God For Life points to protocols developed by the **Front Line COVID-19 Critical Care Alliance (FLCCC)**. "Dr. Lisa Van Bramer, a Pediatric Emergency Medicine specialist, spoke highly of the FLCCC and their treatment approaches. **Math+** is an ethically uncompromised early onset treatment protocol, most effective if started as soon as symptoms emerge. **iMASK+** is both a preventative and outpatient treatment, also ethically uncompromised."

## Acting Local: Sanctuaries for Unborn

For 48 years our efforts to end abortion at the national or state level have been blocked. Substantial abortion bans have passed in some states, only to be blocked by federal judges. But now, an idea to approach abortion at the local level is having success.

The local approach was born out of a proven strategy of “sanctuary cities” that was applied in other areas – from deportation of foreigners, to gun ownership, and cities banning the use of plastic bags and Styrofoam.

At the national level, for example, gun ownership is a constitutional right, yet local cities have enacted restrictions on gun ownership. Alternatively, when states have restricted gun ownership, local cities and counties have become sanctuaries to protect gun ownership and refuse to enforce red flag laws.

Mark Lee Dickson, the founder of *Sanctuary Cities For The Unborn*, approached local officials in Waskom, Texas about an ordinance to protect the unborn from conception in their city.

In June 2019, Waskom city leaders voted to create the first Sanctuary City For The Unborn in America. Thirty-two additional cities have now voted to prohibit abortion within their city limits. Without waiting on the Supreme Court, local cities are creating Sanctuary Cities and ending abortion across America!

In May 2021, Lubbock, Texas voters overwhelmingly approved a citizen-led ballot initiative declaring Lubbock to be a Sanctuary City For The Unborn. This immediately halted abortions at Planned Parenthood in Lubbock. Planned Parenthood sued in court and lost, and Lubbock's pro-life Sanctuary ordinance remains in effect.

This local movement to protect the unborn has spread beyond Texas to cities in Nebraska and Ohio. This could happen anywhere!
